The Leadership Council meeting of Safe & Sound Hillsborough was held on Tuesday, April 24, 2018 at the Children's Board of Hillsborough County. It began at 1:10PM; Chair Holt presided over the meeting. Meeting was properly noticed, and a quorum was present.

Approval of Minutes

*A motion to approve the minutes of the March 27th meeting was made by **Ms. Cindy Stuart** and seconded by **Chief Ken Albano**, passed unanimously.*

Old Business

- Status of the MHFA grant provided; VOCA funding was not secured; grant received from the Kiwanis Foundation to be divided in two payments - \$5k to be received this fiscal year and \$5k to be received by October 1st (new fiscal year); still seeking grant from the Children's Board of Hillsborough County.
- Discussion of the CDC Audit
- Update on Safe Routes to Parks; grant award provides funding for action plan development and technical assistance.
- Update on SafeSummit'18 Violence Prevention Conference; 144 total registrations received to date; Mr. Barton informed members on the confirmed speakers for the conference which include Bobby White (Basketball Cop), Roderick Patterson (Sir Rod), Koran Bolden); Mr. Barton informed members of the cost of the speakers which was discussed in the Finance Committee; discussion of the 2018 PSA to be filmed by Blake High School Students

New Business

Finance Committee Report was presented by Ms. Cindy Stuart

- Discussion of SSH expenditures; no issues reported; **Ms. Stuart** informed members that outreach efforts in South County (Wimauma, Ruskin, Riverview) were still pending; contract with Wholesome Community Ministries has not been finalized.
- CDC Audit was completed and found to be satisfactory; reflective of programming.

Executive Director's Report was presented by Freddy Barton

Mr. Barton updated members on Safe & Sound's activities through the community outreach coordinator reports for the month of March; which included the Improvement League of Plant City's Community Conversation on Guns in Schools; Sergeant Van Duyne briefed members on the day's events; plans for a follow-up community discussions are in the works to be planned for 1-2 months in the future (date to be determined); members were updated on the Safe Routes to Parks grant, SSH was awarded a \$12,000 to begin working on the action plan for the Safe Routes to Parks Framework which will be focusing on King's Forest Recreation Center and is proposed to include RICH House; SafeSummit'18 registration portal has been updated to include information for volunteers and transportation.
